1. **Eligibility:** The [Pioneer DJ Corporation] [TORAIZ Artist Sound Pack by Kiko Navarro] Promotion (the "Promotion") is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older. Employees of the Sponsor(s), as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible.

 - c. There is no limit to the number of Submissions that an entrant may submit (each a "Submission") during the Contest Period; however, use of any

automated program to enter will result in disqualification, and use of multiple social media accounts to enter will result in disqualification.

- d.
